To protect certain confidential information that may be disclosed by the Johnson County Republican Volunteers ("JCRV") to the "Volunteer" above, they agree that:

- The confidential information disclosed under this Agreement is described as voter lists including voter names, addresses, and voting participation information. JCRV shall provide limited data to individual volunteers within their precinct and/or 5x20 block.
- The Volunteer shall use the confidential information received under this Agreement for the purpose of voter education, get out the vote efforts, updating JCRV data, 5x20 activities.
- 3. The Volunteer shall protect the disclosed confidential information by using the same degree of care, but no less than a reasonable degree of care, to prevent the unauthorized use, dissemination, or publication of the confidential information as the Volunteer uses to protect its own confidential information of a like nature.
- 4. The Volunteer shall have a duty to protect only that confidential voter information which is disclosed by JCRV via mobile app, printout, presentation, or spreadsheet. Volunteer may NOT sell or give (including viewing) JCRV voter data to anyone. Volunteer may NOT disclose JCRV voter data to political campaigns.
- This Agreement imposes no obligation upon the Volunteer with respect to confidential information that becomes a matter of public knowledge through no fault of the Volunteer.
- 6. The Volunteer does not acquire intellectual property rights under this Agreement except the limited right of use set out in paragraph 2 above.
- 7. Volunteer understands and agrees that disclosure of JCRV voter data to anyone outside of the JCRV including political campaigns is prohibited and that such disclosure may result in access to JCRV data being terminated and volunteer

- being expelled from JCRV membership. Any monies made in connection to disclosure of JCRV voter data shall be forfeited to the JCRV. Volunteer will pay for JCRV's attorney's fees and collection costs should legal action be necessary to enforce this agreement.
- 8. Upon JCRV's request, the Volunteer shall return to JCRV or destroy all written material or electronic media and the Volunteer shall deliver to JCRV a written statement signed by the Volunteer certifying same within 5 days. JCRV may disable mobile app access at any time.
- 9. The parties do not intend that any agency or partnership relationship be created between them by this Agreement.
- 10. All additions or modifications to this Agreement must be made in writing and must be signed by both parties.
- 11. This Agreement is made under and shall be construed according to the laws of the Texas.
- 12. PROPRIETARY KNOWLEDGE AND METHODS USED BY THE JCRV WILL NOT BE SHARED OR GIVEN TO ANYONE WITHOUT THE EXPRESSED PERMISSION OF THE JCRV STEERING COMMITTEE
